

# Marvel Sinks Limited Warranty

## Sinks

Marvel Industries warrants its sinks to be free from manufacturing defects in material and workmanship, under normal residential usage for the life of the sink while in possession of the original owner.

## Faucets

All faucets installed in a private residence will carry a limited lifetime warranty on all mechanical parts to be free of manufacturing defects in material and workmanship under normal use. All finishes carry a five (5) year warranty from the original date of purchase.

## Accessories

Marvel Industries, warrants the quality of its Marvel Sinks accessories to be free from manufacturing defects for a period of one (1) year from the date of purchase.

This warranty applies only to the original owner, providing the product has been installed in accordance with our installation instructions, used as recommended and in a normal residential application. In the event of a warranty claim, the owner will be required to provide proof of purchase—save sales receipt.

This warranty covers all components which make the product operational. Marvel Industries, at its option, may repair or replace the product or components necessary to restore the product to good working condition. Marvel Industries reserves the right to inspect the installation prior to the actual replacement of the product or component part.

This warranty does not cover misuse or abuse, accidental damages, scuffs or scratches, improper installation, abnormal usage, negligence or damage caused by improper maintenance or cleaning. Normal wear of parts is excluded from the warranty. Damage caused by impurities or acts beyond our control are not covered. Any product or part which has been repaired or altered in any manner outside of Marvel Industries' factory, unless previously authorized in writing by Marvel Industries, will void warranty. Any replacement excludes transportation and any labor re-installation costs. This warranty does not allow recovery of incidental or consequential damages such as loss of use, delay, property damage or other consequential damage, and Marvel Industries accepts no liability for such damages.

The Marvel Industries warranty is limited to the above conditions and to the warranty period specified herein and is exclusive. Marvel Industries DISCLAIMS all other warranties, expressed or implied, including IMPLIED WARRANTIES OF MERCHANTABILITY AND/OR FITNESS FOR A PARTICULAR PURPOSE. These warranties apply only to products used in any of the fifty states of the United States, the District of Columbia, and Canada.
